



SCHOLARSHIP APPLICATION – SUMMER 2012

This application serves three programs: **Camp Alonim**, **Gan Alonim Day Camp**, and **Gesher Israel**. Camp Alonim is part of a not-for-profit entity and is not affiliated with a Jewish community agency or movement. We are able to raise a small amount of scholarship funds from generous families, but the bulk of scholarship awards come from the camp's operating budget. Additional camp scholarship funds have been generously donated by the Jewish Federation of Greater Los Angeles and the Jim Joseph Foundation. The anonymous Camp Alonim Scholarship Committee determines who is eligible to receive aid and awards aid based solely on need.

It is our standard practice not to give financial aid exceeding one-half the cost of tuition for a single session per child at Camp Alonim and one-quarter the cost of tuition at Gan Alonim Day Camp (awards for Gesher Israel are determined on a case-by-case basis). There is no guarantee that an award, if any, will be as high as this standard maximum amount. *So that we may help as many families as possible, we ask that you only request the amount that is necessary for your child(ren) to be able to attend camp.*

The Scholarship Committee will only consider your application upon your child(ren)'s confirmed online registration for Summer 2012 (or, for Gesher Israel, your child(ren)'s completed application) **and** when *all* of the following have been received in our office:

1. A completed scholarship application form (one form per child).
2. A separate sheet of paper detailing the reasons for your scholarship request.
3. Copies of your completed and signed 2010 or 2011 Federal tax returns, including any attached schedules. We strongly prefer to receive 2011 tax returns. (NOTE: If you are submitting scholarship applications for multiple children, you need only submit one set of tax documents with the application forms.)

Please do not mail incomplete application packets. Completed scholarship application packets should be mailed as soon as possible after enrollment. **Incomplete application packets *cannot* be considered.**

The priority deadlines for submitting scholarship applications (including copies of all required tax forms) are as follows:

Gesher Israel:	February 13, 2012
Camp Alonim:	March 1, 2012
Gan Alonim Day Camp:	April 2, 2012

Scholarship applications for campers who enroll after these dates will be reviewed as remaining funds permit. The Scholarship Committee will review applications and you will then receive written notification.

In keeping with the highest levels of *tzedakah*, it is our goal to honor your confidentiality and recognize your place as a valued member of the Alonim community. Although we must require certain documentation and information to process your request for aid, it is not the committee's intention to embarrass families. Camp Alonim is dedicated to helping as many families who are truly in need as possible.
